KickArts Career Kicker Members are invited to submit an EOI to display works on the KickArts Members' Wall within the KickArts Shop. Each month (excluding January) KickArts will highlight the practice of a current KickArts member, through a display on the KickArts Members' Wall, a section in the monthly newsletter, and through social media marketing.

Works should be 2D (or 3D suitable for presentation on a wall not plinth), prepared for display with d-rings attached and must not occupy a space wider than 1400mm or higher than 1800mm. Multiple smaller works are encouraged. All works must be for sale – there is no minimum or maximum price limit.

We are currently calling for EOI's to feature KickArts Career Kickers in this FREE exhibiting opportunity for the months of February – June 2018. Applications will be chosen by a panel including Karina Devine – Director Warwick Art Gallery, and Lenore Howard – Board Director KickArts Contemporary Arts.

Please register your interest by completing the form below and supplying up to 3 images of proposed works or samples of their work that is indicative of the works for display.

Applications must be received by 5pm Friday 12 January 2018.

Applicants must provide up to 3 images of the proposed works. These should be titled using the following format: artist_name_title_date_medium_dimension.

If the works are not yet completed applicants are requested to provide samples of their work only if such work is indicative of the proposed work. If emailing your application, images must not exceed 200kb each.

Conditions of Entry:

- All works must be completed by the person signing this form or as nominated for children under 18.
- Exhibiting artists must be current members.
- **Applications must be received by April 24 2017.**
- All works must be for sale – there is no minimum or maximum price limit.
- 2D Works must not occupy a space wider than **1400mm** or higher than **1800mm**. **Multiples of smaller sized 2D works are encouraged – up to 10 works may be submitted.**
- KickArts will take a commission of **40% + GST** from the retail price listed on this form (i.e. **RRP: \$1000.00; GST Registered Artist price: \$600.00; Non GST Registered Artist price: \$545.45**).
- All artworks must be prepared for display with d-rings attached.
- KickArts reserves the right not to exhibit work that is not prepared for installation.
- Applicants are responsible for the transport to and from KickArts.
- Applicants are responsible for covering transit insurance to and from KickArts.
- Applicants allow KickArts to reproduce images of them and their artwork featured in the exhibition for reporting and marketing purposes.
- **All artworks not sold must be removed from KickArts within 30 days of the end of the shop exhibition or will become property of the organisation.**
